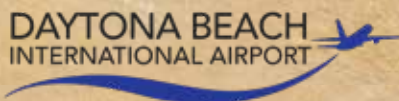

**ADDITIONAL TAXES AND FEES** state taxes and other applicable charges are paid locally. Rental is based on a 24-hour period, beginning at time of pick up and dropped off at the same time on the day of return to avoid any additional charges. Charges may be incurred for any extension from the time of original pick-up. Airport fees may add up to 20% depending on some airport locations.

**MINIMUM / MAXIMUM RENTAL** minimum rental of three days / maximum rental of 28 days.

**GASOLINE POLICY** renter is provided with a full tank of gas. Car must be returned with a full tank of gas or the renter will pay a refuelling charge.

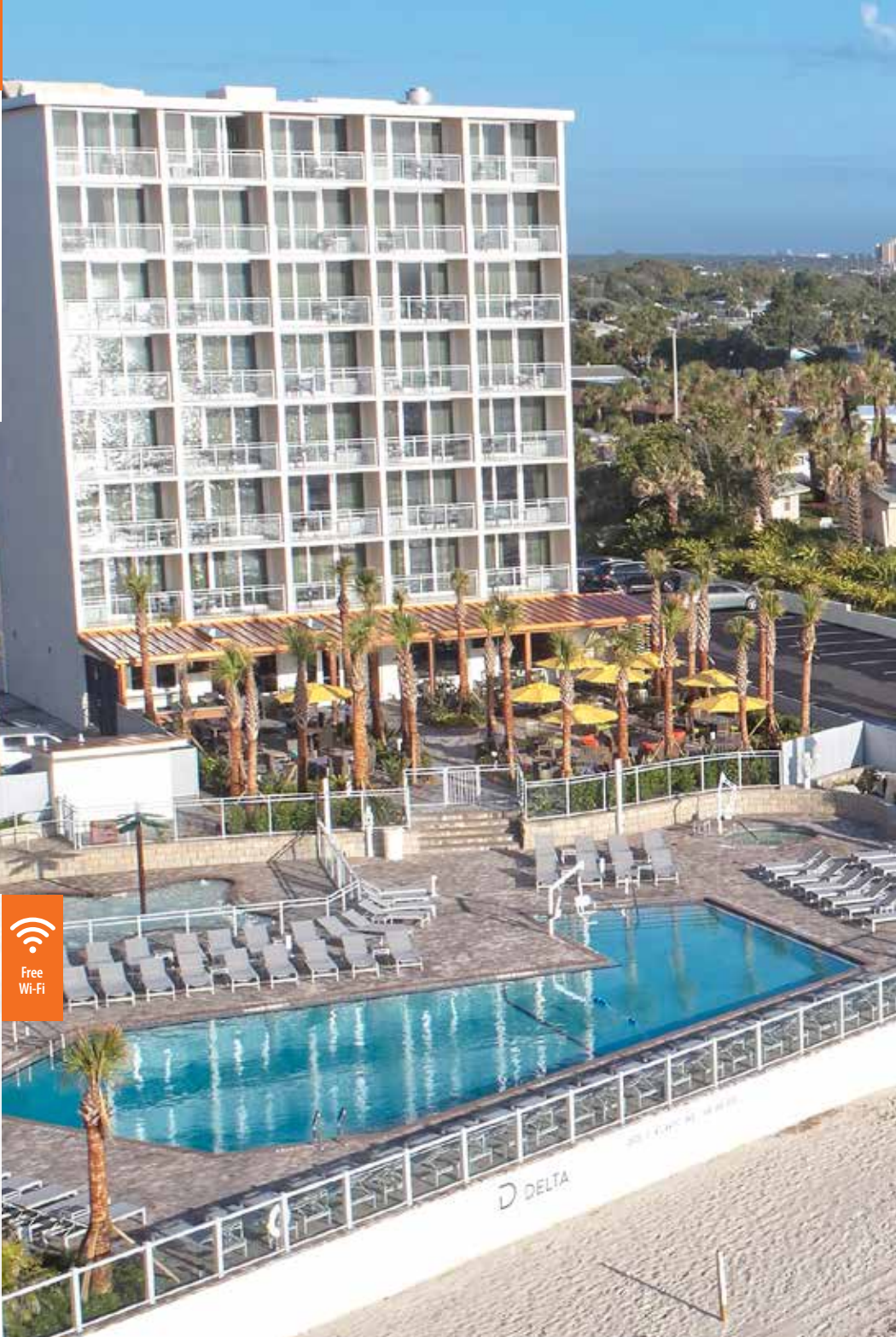

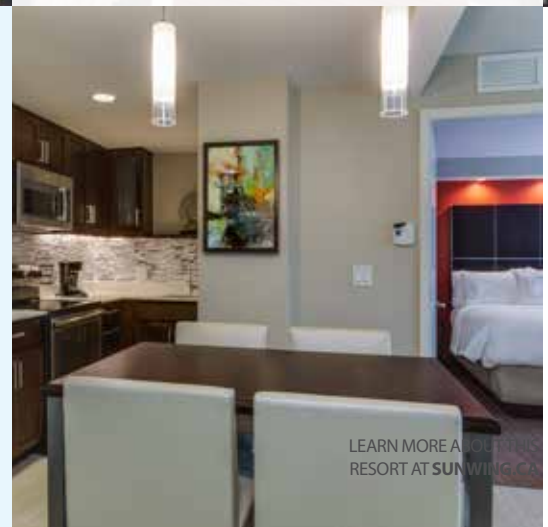
